




■ Terminal Arrangement/Internal Connections (Top View)




LED forward current vs. Ambient temperature




Continuous load current vs. On-state voltage




Turn ON, Turn OFF time vs. LED forward current




Output terminal capacitance COFF/COFF(ov) vs.Load voltage




Continuous load current vs. Ambient temperature




On-state resistance vs. Ambient temperature






LED forward current vs. LED forward voltage




Trigger LED forward current vs. Ambient temperature
